FARMER Program

The California Air Resources Board (CARB) is holding a [workshop](#) to gather input on its Funding Agricultural Replacement Measures for Emission Reductions (FARMER) Program. The FARMER Program provides financial incentives to replace harvesting equipment, heavy-duty trucks, pump engines, tractors, and other equipment that's used in agricultural operations for the purpose of reducing emissions. The workshop will focus on implementation of the program in the 2018-19 fiscal year. In 2017-18 the FARMER Program received \$135 million and an additional \$132 million was provided by the legislature for the 2018-19 fiscal year.

The workshop is being held **December 18 from 10:30 to 12:00 at the San Joaquin Valley Air Pollution Control District office in Fresno**, with video conferencing available at the District's Modesto and Bakersfield offices. CARB staff is planning to provide an update on the status of the implementation of the program and accept feedback on implementation for the upcoming year. Land Use

The Strategic Growth Council has approved \$47.9 million in grant funds derived from Cap and Trade funding through the Sustainable Agricultural Land Conservation Program (SALC) to fund 17 agricultural conservation easements in 13 counties, including Yuba, Sutter, Monterey, Shasta, Santa Clara, Marin, Sonoma, Fresno, San Joaquin, San Luis Obispo, Madera, Sacramento and Sierra. *Staff contact: Taylor Roschen, troschen@cfbf.com or 916-446-4647.*

The Strategic Growth Council, in coordination with the California Department of Conservation, has released a call for qualified contractors who can provide technical assistance to selected technical assistance recipients for the Sustainable Agricultural Lands Conservation Planning Grants component of the Sustainable Agricultural Lands Conservation Program (SALC). The goal of the technical assistance program is to support cities and counties by addressing needs to advance skills in conservation easement plans and policies, developing viable projects and submitting grant applications. To accomplish this, Contractor will conduct outreach to cities and counties to understand interests, assess local needs, develop and implement training curriculum, assist in the development of eligible grant projects and application development, and, if a TA Recipient is awarded a grant, assist with the implementation of the grant project. Though County Farm Bureaus may not be the appropriate entity to apply for this contracted position, we do encourage them to distribute this information to local land trusts and other organizations with expertise in municipal planning and agricultural conservation easement elements. Proposition 65

The Office of Environmental Health Hazard Assessment (OEHHA) have proposed regulatory changes to the provisions of Proposition 65, which would, in response to the *Beechnut* case, require the use of arithmetic mean to determine exposure rates rather than also geometric means, and clarify averaging must be done on individual lots rather than a product-wide basis. This may mean that food producers and processors that have food products which contain Prop 54 listed chemicals, may have to change how they evaluate their exposure levels.
